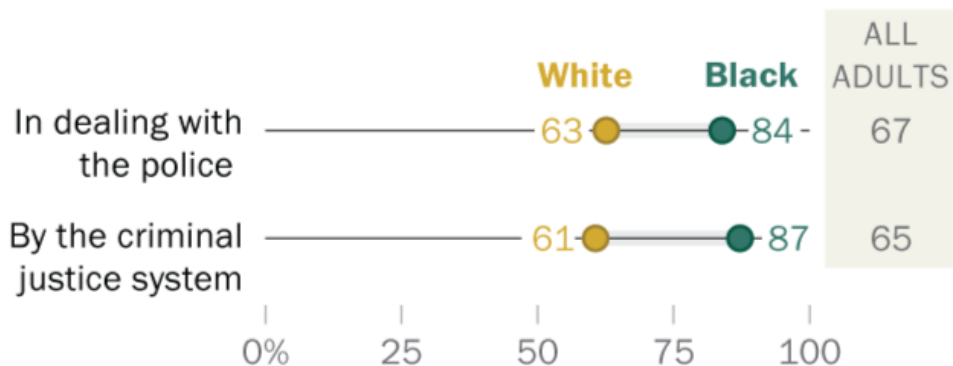

*% who say, in general in our country these days, blacks are treated less fairly than whites ...*



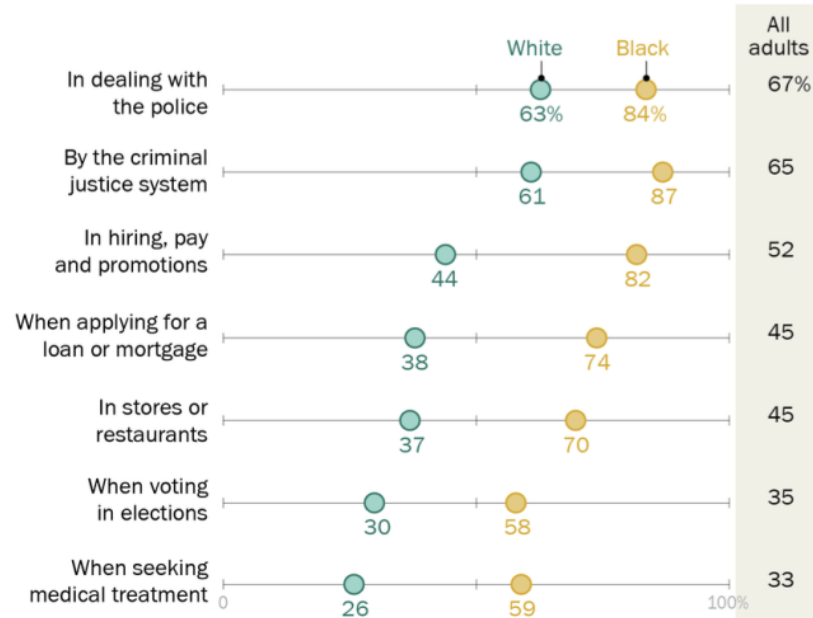
